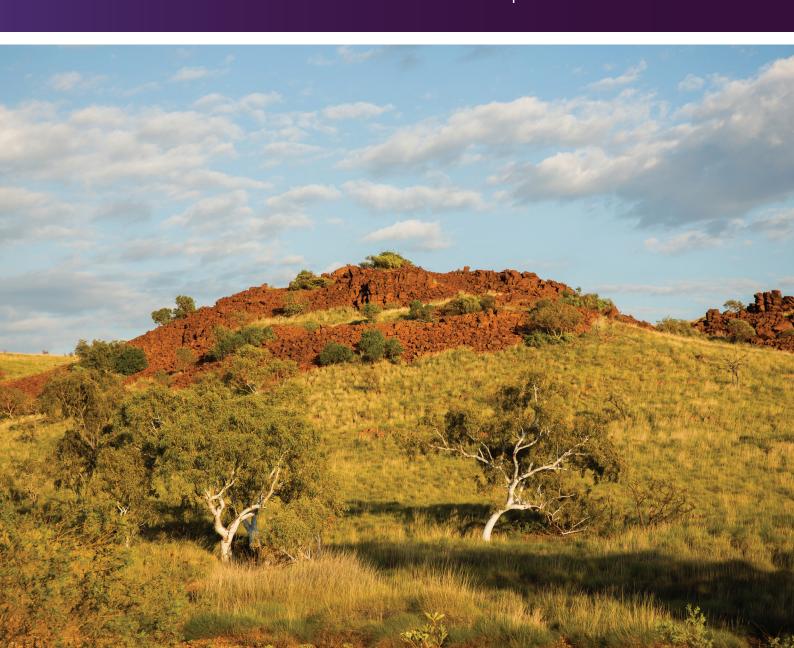

Acting Chair's report

I am pleased to present the 2023-24 Annual Report of the Western Australian Local Government Grants Commission (the Commission).

The Commission is a statutory body established under the *Local Government Grants Act 1978*. Its principal function is to make recommendations to the Minister for Local Government on the allocation of Commonwealth Financial Assistance Grants to Western Australia's 137 local governments.

Over the past 12 months, the Commission held public hearings with 18 local governments regarding grant methodology. These helped the Commission to better understand the needs and challenges facing local governments.

Hearings at the shires of Derby West-Kimberley, Halls Creek and Wyndham East-Kimberley were particularly helpful for the Commission to understand the circumstances confronting those local governments.

I would like to thank all 18 local governments for their willingness to engage in these hearings. I would especially like to thank the Shire of Ashburton for providing the Commission fuel when, due to maintenance issues, there were no functioning refuelling facilities available in town and the Commission had a tight timeline of hearings to conduct!

The National Grants Commission Conference for chairs and executive officers was held in November 2023 and was hosted by the Tasmanian Grants Commission. This bi-annual conference always provides a great opportunity for all participants to discuss best practice examples and major projects that each state may be working on.

During this year, the Commission faced some challenges including ameliorating issues caused by the 100 per cent advance payment (over and under payments) of the 2023-24 FA Grants. While the Commission intended to redistribute all of the over and under payments this year, unfortunately this was not possible due to the operation of the *Local Government (Financial Assistance) Act* 1995 (Cth). It is hoped the redistribution of these funds will be completed by the 2025-26 FA Grants. We will continue to communicate with affected local governments throughout this process.

I would like to thank all Commission members for their dedication over the past 12 months. I would also like to thank Cr Dan Bull for his expert guidance as Chair of the Commission from June 2023 until March 2024. Cr Bull's knowledge, experience and contribution was highly valued, and we appreciate his commitment to the Commission during his term.

With the end of this reporting period, I note that some appointments were made to the Commission. I wish to congratulate Ms Melinda Prinsloo who has been re-appointed for a further three-year term. I also wish to congratulate Cr Christopher Mitchell who has been re-appointed as Ms Prinsloo's deputy.

Some of the current appointment process is still ongoing and I would like to take this opportunity to personally recognise and thank Mr Colin Cameron who has served on the Commission for the past three years. Mr Cameron is the Chief Executive Officer of the City of Subiaco and a former senior local government financial officer. He provides a unique and invaluable perspective of the issues

confronting local governments from an operational viewpoint and the effect of the decisions made by the Commission. Mr Cameron's experience, dedication, and professionalism are commendable.

I would also like to recognise Cr David Goode who as Mr Cameron's deputy only had a limited opportunity to work with but appreciate his willingness to attend commission meetings and visiting programs when called upon.

Finally, I would like to acknowledge our executive staff, without their support the Commission would not be able to operate. To Taryn Cox, Haa Truong, Nicholas Harmer, Dr Chris Berry, Leah Horton and Julie Craig and all the others who have assisted during the past year, we appreciate the professionalism you continue to demonstrate, to always ensure that the Commission continues its important work within the sector.

The Grants Commission

Grants Determination Process

The Commission maintains its administrative processes to provide for timely notification of grants to local governments. The Commission approved (out-of-session) the Final Grant Schedule of FA Grants 2024-25 on 5 August 2024. The Western Australian Minister for Local Government approved the Commission's final allocation of FA Grants on 12 August 2024, with the Commonwealth Minister for Local Government approving the final grant allocations on 13 August 2024.

The Schedule of Payments contains all the information relating to each local government's FA Grants, including general purpose grants, road grants and special project grants where applicable. The Balanced Budget details the calculation of each local governments general purpose grant. Both documents are available on the DLGSC's website at https://www.dlgsc.wa.gov.au/local-governments/financial-assistance-grants.

Public and Special Hearings

In accordance with the *Local Government (Financial Assistance) Act 1995* (Cth), the Commission undertakes public hearings with local governments. The hearings consist of a formal presentation about the operations of the Commission. At the hearings, local governments are given the opportunity to present submissions to the Commission on their individual grant determination and any issues relevant to the grant determination process.

The hearings facilitate discussion between local government councillors and staff, members of the public, and the Commission. Due to the large number of local governments in Western Australia, the Commission aims to hold public hearings with each one at least once every four years. Through these hearings, the Commission can gain a greater understanding of the issues affecting local governments and their capacity to provide services and facilities to their communities.

The Commission tries to ensure that all local governments and other interested parties have the opportunity to understand the grant determination process and to present their views or suggestions on any aspect of the process.

In 2023-24, the Commission held 18 public hearings.

In addition to the public hearings, local governments can request a special hearing with the Commission at any time. This provides any local government with an opportunity to present a submission on the grant determination process to address issues of an urgent nature.

Issues raised at public hearings

As part of the hearings, the Commission provides an opportunity for local governments to raise methodology related issues as well as more general concerns that go beyond the scope of the Commission, to offer guidance and to raise awareness of issues affecting other local governments.

Over the past 12 months, local governments raised the following general issues and matters of interest with the Commission:

- housing availability and costs
- staff attraction and retention
- safety/security of staff and maintenance
- road conditions and maintenance
- tourist impacts on local infrastructure
- climate/heavy rainfall
- fuel/freight costs
- fire mitigation costs.

Local government submissions

Each year, local governments are given the opportunity to highlight disadvantages they face in the provision of local government services through submissions to the Commission.

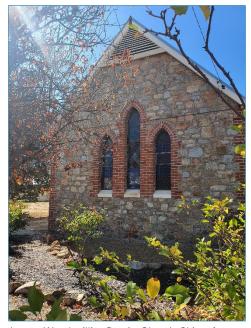

In 2023-24, the Commission received three formal submissions, from the Shire of Derby-West Kimberley, Shire of Gingin, and City of Bunbury.

Any decision made on the submissions will be implemented and reflected in future grant determinations.

Financial Assistance Grants

2024-25 Grant allocations

The Local Government (Financial Assistance) Act 1995 (Cth) provides for an annual adjustment to the national funding pool for the general purpose component of the Financial Assistance Grants (FA Grants) which is calculated by indexing the previous year's funding pool by Consumer Price Index (CPI) and population growth. The annual increase to the national funding pool for local road grants is calculated by indexing the previous year's funding pool by CPI. The legislation also provides for the Commonwealth Treasurer to vary this adjustment if there are considered to be special circumstances.

The Western Australian share of Commonwealth funding for 2024-25 is \$400,140,692 being 12.21 per cent of the national allocation of \$3,277,189,002. Western Australia's share consists of \$246,131,716 for the general purpose funding and \$154,008,976 for the local roads funding and special projects compared to \$377,625,444 (pre-adjustment) of the total funding for 2023-24 FA Grant.

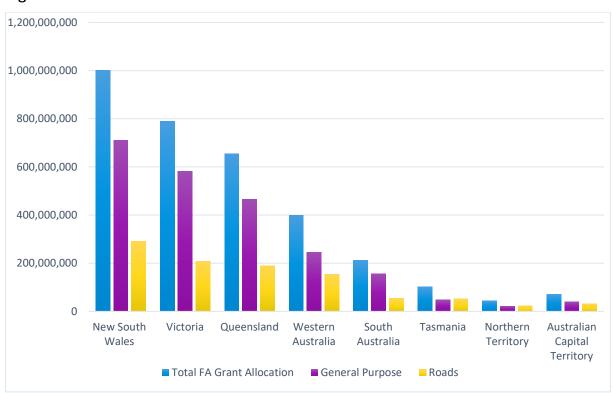


Figure 1. National distribution of Financial Assistance Grants 2024-25

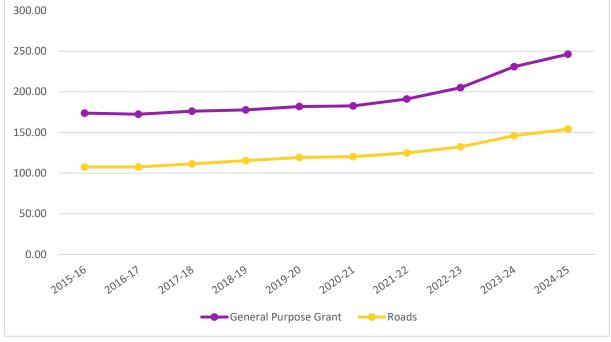

The final amount of FA Grants to be distributed for 2024-25 is \$5,890,403 million higher at \$399,565,984 to reflect a negative adjustment of \$574,708 to the 2023-24 state allocation. This is a result of the Commonwealth rectifying an underpayment of grants made to Western Australia in 2023-24 due to adjustments to the estimated state population and inflation used in the previous year's grant calculation. This year's allocation for Western Australia consists of an increase of \$14,769,192 for general purpose grants and \$7,746,056 for local roads and special projects.

The Commission calculates the "equalisation need" for general purpose grant funding for all local governments, based on calculations of the revenue-collecting capacity of each local government, and magnitude of expenditure each local government would be required to incur to deliver a consistent general standard of services across the state.

The total general purpose grant funding received by the state is commonly less than the total equalisation need calculated by the Commission. For 2024-25, the total statewide general purpose grant funding was approximately 68.8 per cent of the calculated statewide equalisation need.

In 2024-25, the general purpose grant funding received by the State allowed for 68.8 per cent of calculated grant need to be paid to local governments. Local governments that were assessed to be a minimum grant local government had their grant calculated on a per capita basis in accordance with the minimum grant principle under the *Local Government (Financial Assistance) Act 1995* (Cth). Further detail on these calculations is provided later.

Advance payment of 2024-25

The Commonwealth Government advised in June 2024 that it would make an advance payment of the 2024-25 FA Grants in the 2023-24 financial year. The advance payments were calculated by the Commonwealth Department of Infrastructure, Transport, Regional Development, Communications and the Arts and distributed to local governments on 28 June 2024.

This year, the advance payment was lower than the previous advance payment of 100 per cent of WA's estimated 2024-25 FA Grant entitlement, with the State Government receiving 85 per cent of the estimated FA Grant allocation upfront. The advance consisted of a total of \$339,416,207 with \$208,757,650 in general purpose grants and \$130,658,557 in local road grants. This resulted in much smaller quarterly payments due to the remainder of the 2024-25 grants entitlements totalling \$60,616,774 for the state.

The allocation to local governments from the Commonwealth for the advance payments is based on grant recommendations from the prior year (2023-24) with indexation in line with the growth to the grant allocation to Western Australia. However, as detailed in this annual report, the Commission's methodology allocates funding not purely based on indexation of the grant pool but based on a variety of factors to ensure equitable distribution in accordance with the legislation that is appropriate for the state.

While the Commission intended to redistribute all of the over and under payments caused by the 100 per cent advance payment (over and under payments) of the 2023-24 FA Grants, unfortunately this was not possible due to the operation of the *Local Government (Financial Assistance) Act* 1995 (Cth). It is hoped the redistribution of these funds will be completed by the 2025-26 FA Grants.

Unfortunately, this redistribution process has caused unintended confusion within the local government sector, with some local governments understandably contacting the Commission to seek clarification on the grant funding paid.

The amount of the adjustment of grant payments for each local government is outlined in the eighth column in the Schedule of general purpose grants tables on pages [29] to [34] of this report.

Table 2 below outlines the remaining amount of under and over payments that needs to be redistributed in the 2025-26 FA Grant.

Methodology

Each year the Commission implements updated data as provided by local governments as well as undertaking reviews of the revenue standards, expenditure standards and cost adjustors.

These reviews are informed by research and through discussions held on the visiting programs. A copy of the calculations and methodology used can be found on the Commission's website at https://www.dlgsc.wa.gov.au/local-government/local-governments/financial-assistance-grants.

In 2024-25, the Commission determined the following cost adjustors to be of the greatest importance to local government.

Minimum grants

In 2024-25, 32 local governments (of the 137 total in Western Australia) received the minimum grant entitlement which equated to \$25.63 per capita. This was an increase from 2023-24 when local governments received \$24.90 per capita.

Collectively, the local governments receiving the minimum grant accounted for \$56.5 million (23 per cent) of the total general purpose funding pool while comprising 76.5 per cent of the State's population.

Refinements and review of the methodology for 2024-25

The Commission calculates the allocation of the general purpose grants each year in accordance with the Commonwealth National Principles.

For 2024-25, 86.5 per cent of expenditure calculations were distributed using a per capita or per property allocation with the remaining 13.5 per cent allocated by the cost adjustors, to recognise costs which are out of a local governments control.

While the Commission's methodology review is still underway, no major refinements were implemented for the 2024-25 grant determinations. However, there were some minor changes that are noted below.

Revenue standards

Revenue standards are a mathematical formula used to assess the revenue earning capacity of each local government.

The Commission calculates the following revenue standards:

- residential/commercial/industrial rates
- agricultural rates
- pastoral rates
- mining rates
- investment income.

Most revenue standards use regression analysis as the basis to inform the decision. Regression analysis is a tool for analysing relationships between variables.

Residential commercial industrial

The Commission approved the recommendation to use the residential commercial industrial new regression formula of 37.56 per cent on number of properties and 62.44 per cent on valuations.

The final formula is \$726.75 x number of properties + 0.047 x valuations.

Pastoral rates

The Commission approved the recommendation to adopt the regression formula for the pastoral standard of 19 per cent on properties, 33 per cent on valuations and 48 per cent on area.

The final formula was 0.03173 x valuations + 0.01767 x area (hectares).

Mining rates

The Commission approved the recommendation to adopt the mining standard formula of 0 percent on area, 84 per cent on valuation and 16 per cent on number of properties. An adjusted formula was used for Wanneroo, Port Hedland, Ashburton and Kwinana to reflect their significantly higher rating capacity.

Formula for all local governments excluding Wanneroo, Port Hedland, Ashburton and Kwinana. $0 \times area + 0.2590 \times valuations + 927.77 \times number of properties.$

Formula for Wanneroo, Port Hedland, Ashburton and Kwinana. 0 x area + 0.3421 x valuations + 1255.07 x number of properties.

Agricultural

The Commission approved the recommendation to adopt the agricultural standard model weightings of 24 per cent on number of properties, 39 per cent on valuations and 37 per cent on area.

The final formula was \$804.88 x number of properties + 0.0021 x valuations + 3.57 x area.

Investment

The Commission approved the recommendation to adopt the updated investment revenue formula.

The final formula was population x \$17.19.

Expenditure standards

Recreation and culture

The Commission approved the recommendation to adopt the updated recreation and culture standard formula.

The final formula was \$302.88 x population + cost adjustors.

Governance

The Commission approved the recommendation to adopt the updated governance standard formula.

The final formula was \$187.70 x number of ratable assessments + cost adjustors.

Community amenities

The Commission approved the recommendation to adopt the updated community amenities standard formula.

The final formula was \$159.72 x number of ratable assessments + cost adjustors.

Education, health and welfare

The Commission approved the recommendation to adopt the updated education, health and welfare standard formula.

The final formula was \$47.99 x population + cost adjustors.

Law, order and public safety

The Commission approved the recommendation to adopt the law, order and public safety standard formula.

The final formula was \$74.97 x number of ratable assessments + cost adjustors.

Transport

The transport standard figures used are those approved as presented to the Commission out-ofsession on 5 August 2024.

The final formula was factored back transport needs – road preservation grants.

Cost adjustors

Each year the Commission updates the indicator data used in the cost adjustors. This ensures that the calculations are accurate and equitable for the state. For the cost adjustors listed below, updates to indicator data results in changes to state averages.

Medical facilities

The Commission requested that the doctor and nurse practitioner expenditure categories that are recognised through the medical cost adjustor be more specific to recognising the direct cost to local governments. As a result, the final expenditure categories to be recognised now are; doctor (salary/retainer), car, housing, doctors surgery (rent forgone), communication expenses, and other costs.

However, the removal of several previously recognised categories resulted in the allocation to the medical cost adjustor being far more than needed and was allocating up to 120 per cent of local government expenditure. Therefore, the Commission endorsed an 18 per cent increase to the medical cost adjustor, raising from \$85,000 to \$100,000 for the 2024-25 FA Grants calculation. In 2024-25, 11 local governments received the maximum allowance of \$100,000.

Growth data

The Commission updated the historical growth data range from 2016 to 2020, to 2017 to 2021 and the future growth data is updated to 2026 to 2031. The updated historical data means that a range of local governments that previously received an allocation for growth would not be eligible based on the new criteria within the calculation.

Special needs

The Commission provided special needs funding to two local governments in 2023-24: The Shire of Gingin for the financial impact the Lancelin Off-Road Vehicle Area has on the shire, and the Shire of Murchison for the financial impact of being off the power grid. The Commission received and assessed a submission from the Shire of Murchison and in 2023-24 resolved to increase the special needs cost adjustor allocation from \$80,000 to \$120,000 for the 2024-25 FA Grants calculation.

Off-Road drainage

Data on drainage infrastructure and costs are collected every three to five years. Some local governments provided data in 2019, some in 2022, some in both and some not at all. To ensure an equitable distribution of FA Grants the Commission encourages all local governments to provide accurate costs when requested. As a result, there was a significant increase to the assessed off road drainage allowances for 2023-24. The total off road drainage allowance for 2024-25 is \$14.79 million, which is the same as 2023-24.

Transport standard

The Commonwealth's 2020-21 Local Roads and Community Infrastructure Program (LRCIP) funding stream was allocated to local governments largely on the basis of asset preservation needs, even though the funding was not required to be spent on roads.

A total of \$336.7 million was allocated to Western Australian local governments in phases 1 to 3. This included \$73 million provided in phase 1, a further \$117.6 million in phase 2 and \$146.1 million for phase 3. According to the Western Australian Local Government Association Road Assets and Expenditure Report 2022-23, \$97.9 million (29.1 per cent) of the \$336.7 million provided in phases 1 to 3 was spent on roads. As this funding was not necessarily for road asset preservation only, the Commission took 65.3 per cent of this expenditure (\$63.9 million) into account, as this represents the proportion of general local government expenditure on roads that focuses on asset preservation. The effect of this inclusion of 29.1 per cent of the LRCIP is to increase the total preservation grants netted out from the required transport expenditure from \$335.2 million to \$349.8 million. This had the effect of reducing the assessed transport standard expenditure calculated for local governments and resulted in many reductions to local government equalisation assessments.

Local road funding

The Commission calculates the road grant allocations using the asset preservation model (APM) which has been in place since 1992. The APM recognises the maintenance costs based on the existing road assets of each local government and regional differences in the cost of maintenance.

Local road inventory data is a critical input to the APM and local governments are encouraged to maintain comprehensive and up-to-date inventory data.

For 2024-25, Western Australia received \$154,008,976 of the total national local road funding pool of \$1,007,240,310, representing 15.29 per cent of the national total.

Ninety-three per cent of the Commonwealth funds for road grants are distributed to local governments in Western Australia according to the APM.

Under the current methodology, seven per cent of the funds are allocated for special projects; one-third of this is for roads servicing Aboriginal communities and two-thirds is for bridges.

Main Roads Western Australia (MRWA) contributes one third of the cost of projects funded under this program.

The Aboriginal Access Roads Committee advises the Commission on procedures for determining the allocations of Commonwealth road funds for roads servicing remote Aboriginal communities and recommends the allocations that are made each year.

Membership of the committee is made up of representatives from the following organisations:

- Western Australian Local Government Grants Commission (Chair)
- Western Australian Local Government Association
- National Indigenous Australians Agency
- MRWA
- Department of the Premier and Cabinet
- Department of Communities
- · Department of Planning, Lands and Heritage; and
- Department of Local Government, Sport and Cultural Industries.

The committee has established funding criteria based on factors including the number of Aboriginal people serviced by a road, the distance of a community from a sealed road, the condition of the road, the proportion of traffic servicing Aboriginal communities and the availability of alternative access. These criteria have provided a rational method of assessing priorities in developing a five-year program.

Special project funds have been allocated for improvements to Aboriginal access roads over many years, and it continues to be pleasing to see continuing improvements in road standards.

Special projects: bridges

The Commission's policy for allocating funds for bridges recognises that there are many local government bridges that are in poor condition and that the maintenance and preservation of these bridges must be given a high priority.

The special project funds for bridges are only allocated to preservation projects, recognising that some of these projects may include some upgrading and that preservation includes replacement when the existing bridge has reached the end of its economic life.

MRWA contributes one third of the cost of all projects funded under the special projects program.

In 2024-25, the funds for the preservation of bridges are:

The Bridge Committee advises the Commission on priorities for allocating funds for bridges. Membership of the committee is made up of representatives from the following organisations:

- Western Australian Local Government Grants Commission (Chair)
- Western Australian Local Government Association
- MRWA
- Department of Local Government, Sport and Cultural Industries.

The Committee regularly receives recommendations from MRWA on funding priorities for bridges. MRWA inspects and evaluates the condition of local government bridges and has the expertise to assess priorities and make recommendations on remedial measures.

Road costs used in the Asset Preservation Model

A major influence on the increase in total asset preservation needs was the 11 per cent inflation factor applied to the unit costs.

The unit costs were last comprehensively reviewed in 2019, and an inflation factor based on a relevant Australian Bureau of Statistics cost index has been applied each subsequent year to keep the costs current. The inflation factor applied to the 2019 costs for the 2024 assessments was 32 per cent. The larger inflation factor is consistent with industry reports of increasing costs.

A review of unit costs has commenced, with the data collected from local governments currently being analysed. Updated unit costs will therefore be applied in the 2025 determinations.

Distribution of the Asset Preservation Model component

In 2024-25, \$143,249,976 will be distributed in accordance with road preservation needs determined by the Commission's APM. The model assesses the average annual costs of maintaining each local government's road network and has the facility to equalise road standards through the application of minimum standards. These standards help local governments that have not been able to develop their road systems to the same level as other more established local governments.

Accurate road costs underpin the reliability of the APM, which is used for allocating the Commonwealth Financial Assistance local road grants. MRWA also uses the APM assessments for allocating the state's direct (road) grants. The Commonwealth has also used the Commission's APM assessments as a basis for allocating Roads to Recovery (R2R) funding and the Local Roads and Community Infrastructure Program.

Total assessed asset preservation needs in Western Australia increased by 10.5 per cent from \$1.055 billion in 2023-24 to \$1.166 billion in 2024-25, reflecting both increased inventory and significantly increased costs.

Grants to Indian Ocean Territories

The Commission provides advice to the Indian Ocean Territories administration on the level of FA Grants to be provided to the Shire of Christmas Island and the Shire of Cocos (Keeling) Islands. The funding for both shires is assessed separately to the allocation of FA Grants for Western Australia's 137 local governments. Grant funding is allocated directly by the Commonwealth and does not come out of the State funding pool.

The Commission mostly assesses the funding requirements of these two shires in accordance with the same methodology applied to Western Australian local governments. Some specific cost adjustors are applied to recognise the unique situation of the Indian Ocean Territories. The local road funding grant is assessed in accordance with the APM.
