Briefly describe the nature of the agreement or arrangement.

The profit sharer is the Landlord.

 $Agreement\ is:\ on\ top\ of\ the\ rent\ (\$100,000.00\ plus\ GST\ per\ year);\ four\ (4\%)\ percent\ over\ a\ Natural\ Breakeven.$

The Breakeven in the first year of the lease was \$2,500,000.00. (\$100,000.00 divide by 4%) The Breakeven will increase annually at the same time as the net rental is reviewed. For clarification, the tenant will pay 4% of all income over \$2,500,000.00 to the Landlord.

What monetary benefits will the licensee and the other party gain from the agreement or arrangement?

The Landlord (other party) gains 4% of all income over \$2,500,000.00.

The licensee gains the opportunity to lease a property in a highly desired location; the monetary benefit is that it has arguably cheaper rent than normal industry standard for the location, which is a failsafe in case business turns sour; however countered by the four percent over a Natural Breakeven. So the more the business succeeds, the greater revenue for the licensee and the greater monetary benefit for the Landlord (other party).

Since opening on 14 December 2023 and having an extremely busy year of trading; the forecast is extremely favourable for the future success of Froth Craft Beach; and a tavern liquor license would help enable greater revenue, predominantly via the increased capacity, and also the increased diversity of liquor sales; namely the ability to sell limited takeaway packaged liquor (explained in detail in the attached P.I.A).

- 1. Maintain responsibility for the conduct of the business under the licence and have total control of the management and supervision of the operation of the business conducted under the licence;

4. Maintain total control of the business bank account and distribution of any proceeds from the business conducted under the licence.
