



# Licence Checklist

## Producer's Licence

This checklist is a risk assessment tool that can help your premises become and remain compliant with the liquor laws. It is a valuable tool to have and we encourage you to use it regularly to ensure you are complying with the *Liquor Control Act 1988*, *Liquor Control Regulations 1989* and your liquor licence.

This checklist addresses important legislative requirements such as signage and documents, supervision and management, training, responsible service of liquor and juveniles.

## A 'NO' ANSWER MAY BE A BREACH AND REQUIRE FURTHER INQUIRY

This section operates under the *Liquor Control Act 1988* and *Liquor Control Regulations 1989*

S116(4)	Is there a notice displaying the name of each person who is supervising and managing the premises and identifying each such person as a manager (only required if name of managers not included in signage located at or near the front entrance)?		
S116(1)	If applicable, is your <b>extended trading permit</b> kept on the licensed premises and available for inspection by an authorised officer?		
S116(1)	Is your current <b>plan(s)</b> approved by the licensing authority in respect of the licensed premises kept on the licensed premises and available for inspection by an authorised officer? Is the plan accurate?		
S116A(2A)	Is your current <b>plan(s)</b> approved by the licensing authority in respect of a Cellar Door Premises permit kept on the premises to which the permit applies and available for inspection by an authorised officer? Is the plan accurate?		
S3	Is your <b>House Management Policy, Code of Conduct and Management Plan</b> kept on the licensed premises and available for inspection by an authorised Officer?[see Director's Policy <a href="#">Harm Minimisation</a> ]		
S116A & R18EB	Is your <b>Incident Register</b> being maintained and kept on the licensed premises and available for inspection by an authorised officer?		
S103AA(1) & R14AG	Is your <b>Training Register</b> being maintained and kept on the licensed premises and available for inspection by an authorised officer?		

## SUPERVISION & MANAGEMENT

S100(2a)	Is an <b>approved manager</b> who holds a valid Identification card present at the licensed premises and (if applicable) Cellar Door Operation at approved premises?		
S100(3)	If not, has this person been appointed by the licensee or approved manager as a <b>temporary manager</b> ?		
R14ADE	Does the on duty approved manager have their Identification card with them to present to an authorised officer if directed to do so?		

## MANDATORY TRAINING

S103A(1)(a), R14AD	Has all staff who are involved in the sale and supply of liquor completed the appropriate training <b>within four weeks</b> of commencement of employment?		
R14AG(2)	Do you have copies of <b>Training Certificates</b> on the licensed premises for an authorised officer to view if required to do so?		

## RESPONSIBLE SERVICE OF LIQUOR

S115(2)(a)	Do you have procedures and controls to prevent liquor being sold or supplied to an drunk person if permitted to conduct tastings or consumption on the licensed premises?		
S116A(1)	Have all <b>refusals of service</b> been recorded in the incident register?		
	Are all <b>liquor promotions</b> operated in consideration of the Director's Policy <i>Responsible Promotion of Liquor</i> ?		
S115A	Is <b>drinking water</b> available free of charge to all patrons at all times when free tastings are supplied?		

## JUVENILES

S121(1)	Does your venue have procedures and controls to <b>prevent juveniles being sold or supplied liquor</b> ?

## LICENSEE OBLIGATIONS

S55(1)	Does the sale occur on or from the licensed premises to which the vineyard or production facilities are located and are all postal payments sent to the licensed premises (ie not an office located off the licensed premises)?		
S113A	If authorised to sell packaged liquor and the licensee is advertising, promoting or otherwise facilitating the business carried on under the licence via a website, does the website contain the prescribed wording as described in the Regulations/Director's policy guideline?		
S37(5)	Does the licensee have <b>exclusive rights to occupy the premises including occupying the vineyard or production facilities</b> ?		
S102(1)	Have all changes to the <b>structure of the licensee entity</b> (ie directors and shareholders) been approved by the Director of Liquor Licensing?		
S104(1)	Have all <b>arrangements or agreements</b> that the licensee has entered into under which another person may share in the proceeds of the business been approved by the Director of Liquor Licensing?		
S77(1)	Have all <b>alterations to the premises</b> been approved by the Director of Liquor Licensing?		

## TASTINGS

S55(2)	<b>If tastings is authorised</b> , is the liquor used for the tastings provided by the licensee?		
	Is the tastings being conducted under the full responsibility and supervision of the licensee or approved manager at all times?		
	Are the tastings provided in samples not exceeding the prescribed amount if provided free of charge?
