LIQUOR CONTROL ACT 1988

LIQUOR CONTROL (SECTION 31) NOTICE (No. 2) 2020

Issued under the *Liquor Control Act 1988* ('the Act') sections 31(6) and (7) by the Director of Liquor Licensing. This notice revokes Liquor Control (Section 31) Notice 2020.

1. Citation

This notice is the Liquor Control (Section 31) Notice (No. 2) 2020.

2. Commencement

This notice comes into operation on the day on which it is published in the *Gazette*.

3. Term used in this notice

- "customer" means a person other than a liquor merchant as defined by section 3 of the Act but does not include a person outside of Western Australia;
- "relevant licence" means any hotel licence, hotel restricted licence, tavern licence, liquor store licence, club licence, wholesalers licence or special facility licence granted before or after this notice comes into operation;
- "**producers'** licence" means a licence issued under section 55 of the Act or a special facility licence the conditions of which authorise the sale of liquor in the manner set out in section 55(1);

4. Interaction of this notice and other conditions on licences

- (a) A condition imposed by this notice on a relevant licence is in addition to any other condition to which the licence is subject.
- (b) If there is a conflict or inconsistency between a condition imposed by this notice on a relevant licence and any other condition to which the licence is subject, the more onerous condition prevails.

5. Additional conditions applicable to licences

- (a) Each relevant licence is subject to a condition that the licence does not authorise the sale of packaged liquor in excess of the following quantities per customer per day—
 - (i) 11.25 litres of beer, cider or pre-mixed spirits (eg. one carton or a combination of each kind of liquor up to 11.25 litres); or
 - (ii) 2.25 litres of wine (eg. 3 bottles); or
 - (iii) 1 litre of spirits; or
 - (iv) 1 litre of fortified wine; or
 - (v) a combination of any two of (i), (ii), (iii) or (iv) above but not a combination of two of the same product.
- (b) Each producers' licence is subject to a condition that the licence does not authorise the sale of packaged liquor in excess of the following quantities per customer—
 - (i) 11.25 litres of beer, cider or pre-mixed spirits per day (eg. one carton); or
 - (ii) 9 litres of wine per week (eg. 12 bottles); or
 - (iii) 1 litre of spirits per day; or
 - (iv) 1 litre of fortified wine per day; or
 - (v) a combination of any two of (i), (ii), (iii) or (iv) above but not a combination of two of the same product.

6. Term of notice

This notice remains in force until amended or revoked.
